Good afternoon. I have been asked to circulate the information below to both Councillors and Community Councils by Jan Little in Roads regarding parking charges, etc.

As agreed at the Council Meeting on 25 June 2026, the Council will be introducing changes to parking tariffs, charging days and hours in Pay and Display car parks, along with a new digital permit scheme. The changes are now being finalised through the Traffic Regulation Order process and will come into effect on 1 October 2026. Public information will be issued shortly, and advisory signs will be displayed in car parks to notify drivers of the changes.

For ease of reference, a summary of the changes is provided below for your reference.
